5597 Financial Position 14 February 2020

The clerk had circulated to Councillors the latest financial position of the Parish Council which related to 13 March 2020.

5598 Gardening Contract

The clerk had circulated information on the gardening contract. The areas identified in the contract were:

- ❖ Tintagel.
- ❖ Hordens.
- ❖ Kentmere.
- ❖ Eclipse.

The annual number of cuts would be 7 per annum (April to October) and the number of hours required would be 6.5 hours per month. Contractors would need to provide an hourly rate, and include in the price litter picking/ the removal of all rubbish. Any extra work would need to be agreed by the Parish Council. The clerk had reviewed the information and a notice would be placed on the noticeboard for prospective bidders to quote for the work. Due to the current position with the Coronavirus this still needed to be done.
