5401 Apologies for Absence

5402 Declarations of Interest

5405 Planning

There were two planning applications on the schedule.

Councillors had no objections to the planning applications.

Councillor D Hardman advised the clerk that there would be planning applications relating to the Sappi Site and the Pleasington Lakes Scheme on Brokenstones Road. The latter scheme had been completely changed to include housing and he advised that the Parish Council needed to object to this scheme when it received the planning application. Councillors were asked to forward their objections to the scheme to the clerk.

Action: the clerk to object to the Pleasington Lakes Scheme following receipt of information from the Council/Parish Councillors.

5406 Rosebay Wood

There was no further update for the meeting.

5407 Defibrillator for the Parish Hall.

Cllr Simm had received a quote from Defib- Store for the Defibrillator at a total cost of £1732.80. Due to the cost it was agreed that two more quotes would be required. The Parish Council had also received correspondence from London Hearts a Charity who were promoting defibrillators.

5408 Litter Signs for Livesey Parish

Cllr Simm had ordered 20 signs from Douglas signs at a total cost of £108.00 which would need to be paid for. He would position the signs at appropriate areas within the Parish.

Actions: Cllr Simm to put up the signs around the Parish. The clerk to pay the invoice total of £108.00 to Douglas Signs.

5409 External Cladding for the Hall

Cllr Simm would get three quotes for the cladding and present them at a future meeting. It was unlikely that the Parish Council would be able to afford to get all the work done in one go, so it may have to be phased over a number of years.

Action: Cllr Simm to get three quotes and bring them to a future meeting.
